The existing building consists of three flats, owned by me, and a cellar, owned by someone else. The cellar has separate access and is under a separate title at the Land Registry. This application for a conversion is an update to the approved combination of two of the three flats two years ago (2021 application, under no. PP-9940217).

Both Flat A (middle floor) and the Ground Floor flat are unoccupied and in a state of disrepair. Since the 2021 certificate was granted, I have since bought the third flat and would like to combine that into the scheme too.

The usage of the building remains the same - it is still going to be a residential dwelling - and it allows me to repair the building and bring it back up to a good state.
